


Take HEADBAND FRAME, insert forehead strap into center curved slot. TIP: Curved slots adjust nose-to-shield distance. 3 settings available.



TRANSPARENT SHIELD


Attach TRANSPARENT SHIELD to
HEADBAND FRAME using corresponding 3
holes on shield & 3 tabs on headband. TIP:
Tabs are bendable.



ELASTIC BAND

Loop ELASTIC BAND between two
large tabs at back of HEADBAND FRAME.

TIP: 3 fit sizes can be achieved using inner-inner, inner-outer, or outer-outer tabs.



Elastic cap/bouffant (not included) can optionally be stretched over the upper edge & tabs of HEADBAND FRAME.




